- e) Sealed bids must be submitted to the office **Green Hill City Society, Mulpani** by hand before 03:00 pm on **Ashads 4**. Bid should comprise of two envelope system i.e Technical and Financial. Bids received after this deadline will be rejected.
- f) The bids will be opened in the presence of Bidders' representatives who choose to attend at 4:00 pm **Ashads 4** at the office of **Green Hill City Society, Mulpani**. The Bidder must pass in Technically, then Financial Documents will be opened. Bids must be valid for a period of 15 days after bid opening and must be accompanied by a bid security amounting to a minimum of **3 % of bid amount**, which shall be valid for 30 days beyond the validity period of the bid.
- g) Final agreement shall be done after the negotiation in the bidding amount. Green Hill city Society has the right to accept and reject the bid whole or partial.
- h) If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
